Narrative & Location
<p><b>Narrative:</b></p> <p>I, Cordell D. Clark ASO(Agricultural Standards Officer) IV, on 6/9/2017, tried to contact a 26 year old female, [REDACTED] had left as message with my office the day before. Since she was not home when I tried at 7:30 am, I left a message. [REDACTED] called me back at 8:00 am, at which time she informed me of her concerns in relation to pesticide applications being made to the crop land adjacent to her housing development, The "Homecoming Development" located at [REDACTED] Chino, CA 91708.</p> <p>[REDACTED] told me that she has had severe headaches, fatigue, vertigo and "brain fogs" for the past month or so. She told me that she and her family had had to move out of their previous house in Chino about 6 months prior to this, because the house had mold problems. Since that time, she and her family have had a sensitivity to chemicals, and she is very cautious about chemicals and their use. I asked her if she has sought medical attention for her current physical problems, and she told me she has not.</p> <p>[REDACTED] told me that she had seen water being sprayed on the crop land by her and that it was coming out of posts, several of them, and that the fields were South and west of her housing development. She asked to be notified of the results of my investigation.</p> <p>With the help of the Assistant Agricultural Commissioner /Sealer, Allen Lampman, I was able to locate the fields in question and determine that they were currently being farmed by Cleveland Farms- Permit #3600430. A request for information from the owner and researching State Use Reports, showed that in the last year, cow manure, compost, and recycled water had been applied to the property. In addition, one pesticide application for weed control, following recommendation # 3710538 and using the following products- Weedone LV 4, Rifle Herbicide, and LI 700- had been applied on 3/9/2017. This application was a full 2 months before [REDACTED] symptoms started. This was the only pesticide application that had been done since 2015. None have been done since, though the fields have been harvested and prepared for the next crop, field corn.</p> <p>No correlation can be drawn between the pesticide application and the onset of [REDACTED] symptoms due to the length of time between them. This investigation is closed.</p>
