On 9-10-18 homeowner called and spoke with Rusty Hall, Agricultural Inspector/Biologist. has an elm, acacia and other trees she believes have been sprayed by her neighbor. The trees show herbicide damage appearing as dead and dying foliage and has grown progressively worse. She noticed the damage about three weeks ago. She has contacted the Morro Bay Police and filed a complaint, but they were not able to prove anything and told her they needed more evidence. She has taken photographs to document the damage. She has also taken samples which she has placed in her freezer. This has also happened about 2 years ago and she has photographs from time. She suspects the herbicide was Roundup. Her neighbors name is Hall and Kim Daum, Agricultural Inspector Biologist, went out to home and spoke with the her and observed the damage on the trees and took photos. Hall and Daum observed what appeared to be herbicide injury based on the type and pattern of the damage. Daum spoke with who admitted to spraying glyphosate on the weeds in his yard about 5 weeks prior but denied spraying her trees. He gave Hall and I permission to enter his property when he is not home to take photos of the trees from his side of the fence. property and took photos. After reviewing the investigation with Ahmed Hall and Daum went out the Elhawary and Catherine Yee it was decided to not take samples.
