SUMMARY

A complaint was filed with the Sutter County Agricultural Department for a drift onto people and property that occurred on August 11, 2019. The drift involved one person in a residential area. No illnesses were reported. The respondent is Yuba City Unified School District. Application date was August 11, 2019 and the complaint was filed the next day. The pesticide applied was Spectracide Weed & Grass Killer (EPA #9688-293-8845); a caution labeled herbicide for household uses. Samples collected on the complainant's property tested positive for Diquat Dibromide, Dicamba, Fluazifop-p-butyl, the active ingredients in Spectracide.

BACKGROUND

On Wednesday, August 11, 2019 at 9:00am, the Sutter County Agricultural Department received a drift complaint from She stated that the school district employee was applying to close too her property and drifting onto her property.

Scott Bowden Deputy Ag Commissioner assigned the investigation to Chris Ramirez, Ag Standards Biologist.

VIOLATIONS

CCR 6614 b (3)

- § 6614. Protection of Persons, Animals, and Property.
- (b) Notwithstanding that substantial drift will be prevented, no pesticide application shall be made or continued when:
- (1) There is a reasonable possibility of contamination of the bodies or clothing of persons not involved in the application process.

Samples of grass clippings were taken from the treatment site (8/15/19-CR1), one fifeet away from treatment site (8/15/19-CR2) and the third was 10 feet away from treatment site (8/15/19 CR3). After samples were taken, I placed them in the Sutter County Agricultural Lab Fridge.	
On the day of the incident, there was a south wind with speeds recorded at with an average speed of 2mph with a high wind of 10mph, see attached. Samples were taken to the CDFA residue lab on August 15, 2019 at approximately 2:00pm. Sutter County Agricultural received the completed sample analysis report to the CDFA residue lab on December 20th, 2019 and the results showed that the 3 sat taken tested positive. Two samples tested positive for 3 active ingredients and the the sample tested positive for 1 active ingredient. Samples tested values are as follows:	mples nird
